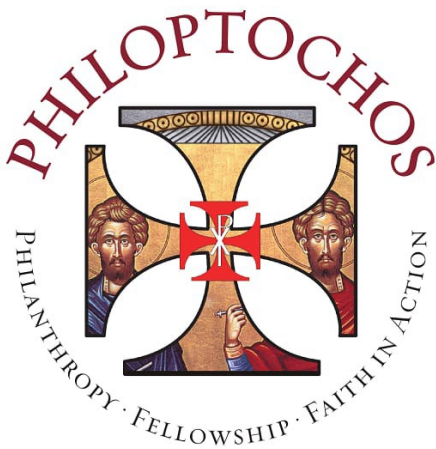

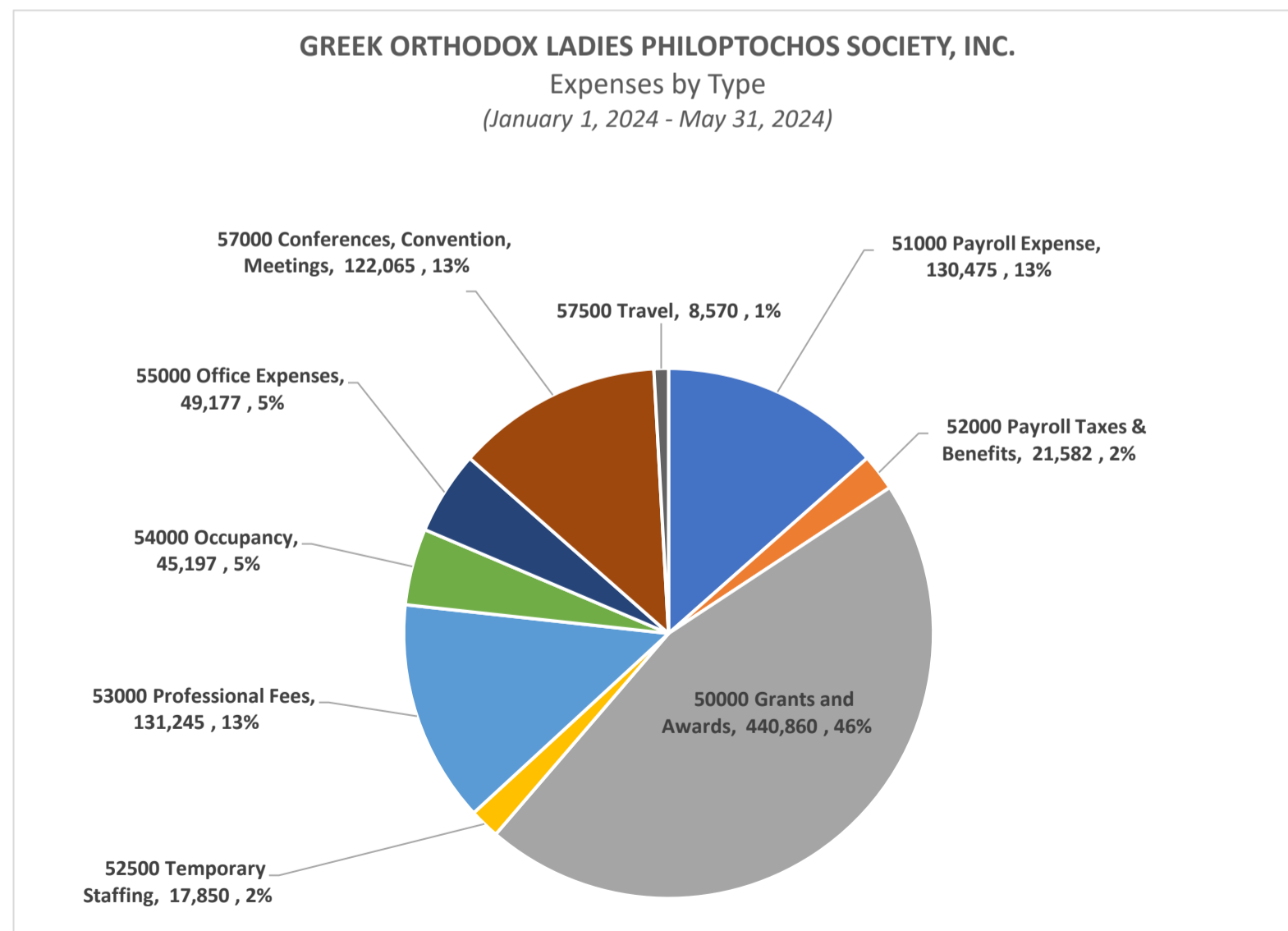
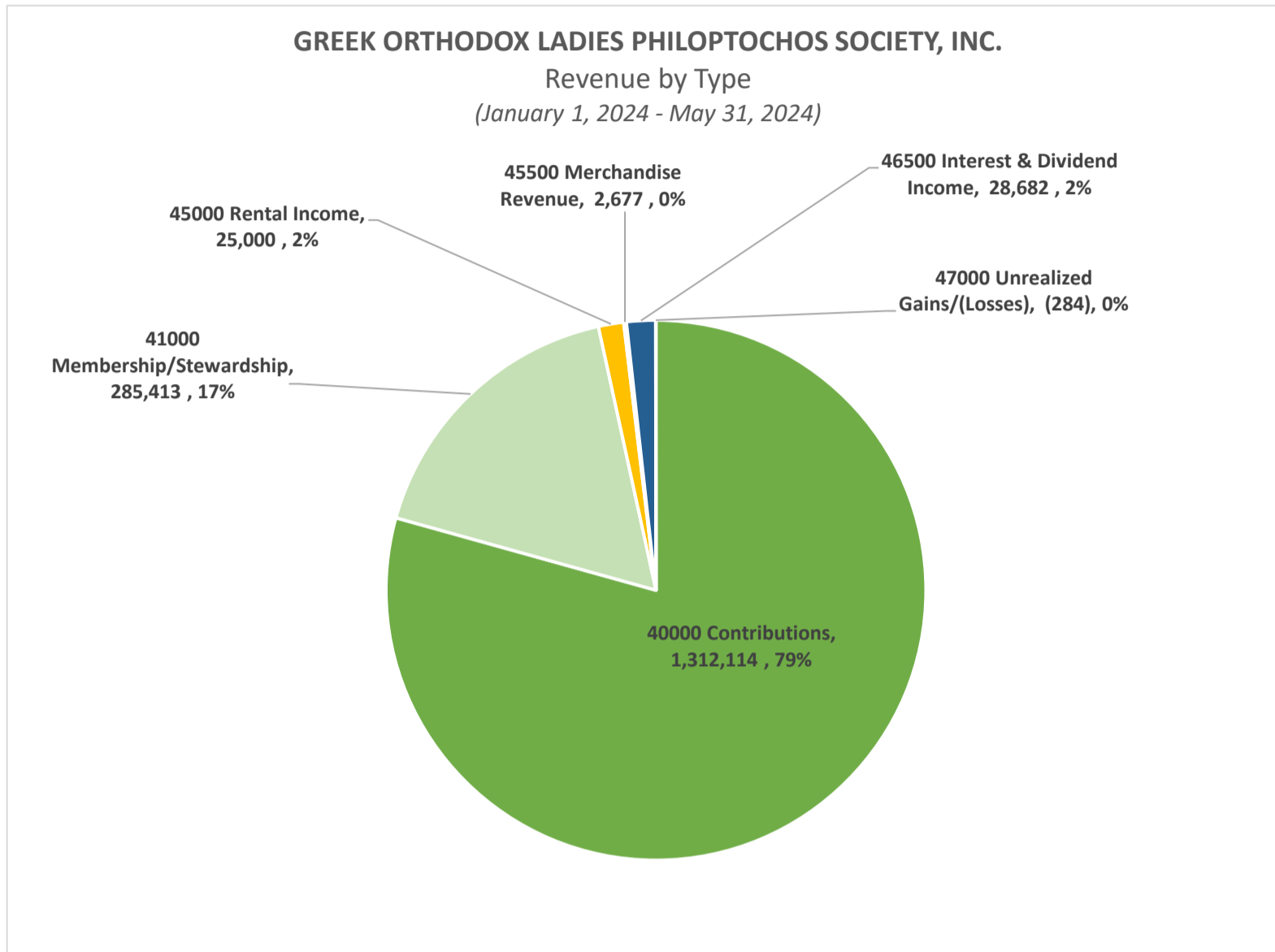
## Revenue and Expense Charts
